SCALE OF CHARGES

PAWNBROKING – Vehicles/technical devices

1. Processing fee:

for a loan		up to EUR 500	EUR 10
for a loan of	EUR 501	up to EUR 1,000	EUR 15
for a loan of	EUR 1,001	up to EUR 2,000	EUR 20
for a loan upwards of	EUR 2,001		EUR 25

Payable when the loan is taken out and each time it is renewed.

a) Loan interest on the secured loan 1.00% per half month

b) Handling fee on the secured loan 0.75% per half month
if the pledge remains in use 1.25% per half month

Payable at the time of redemption, renewal or realisation of expired pledges.

The interest and handling fees are calculated half-monthly until the pledge is redeemed, renewed or auctioned, each half-month started being charged in full.

For pledges that are redeemed or renewed before the end of the first month, the charges and interest are calculated for the full month.

When a pledge is renewed, calculation of the loan interest and handling charges for the pledge duration following the renewal commences on the first day of the calendar half-month following the deposit date and ends on the last day of the calendar half-month in which the pledge is renewed again.

3. Storage charges per square metre, monthly EUR 3.90

Payable at the time of redemption, renewal or realisation of expired pledges.

4. Auction fee for expired pledges: on the highest bid 18%

Charges for sale on the open market of expired pledges:
on the sale value 18%

Cancellation fee*) on the loan 5%

including VAT on the margin scheme

5. Warehousing charge

for redeemed pledges that have not been collected *) 2.4% of the loan amount per month or part-month from the time of redemption

6. Processing fee for notifications of loss and postponement of sale*)
per pawn ticket EUR 7.20

7. Reimbursement of expenses

All expenses incurred in connection with a transaction by the pledger, such as expert assessment, safekeeping/garaging, warehousing, transfer, collection and commensurate costs in the event of realisation and cancellation, must be reimbursed to the company.

Payable at the time of redemption, renewal or realisation of expired pledges.

Please note:

Unless indicated otherwise on the pawn ticket, the **insurance value** is one-and-a-half times the loan.

The **renewal** of a secured loan will be treated as if it were a new loan for the purposes of calculating interest and charges.
